(6) Creating an alcohol, tobacco, and drug free environment during practices and games (7) Contributing to the development of safe physical and positive psychological environment for all. (8) Supporting the vision of: Competing and Winning with Honor / Play your Best, Play Fair , Every person wins. [D] I will be knowledgeable in the rules of each facility /activity my child attends, and I will go over these rules with my Child. [E] I will remember that I am a youth sports Parent / Guardian, and that the game is for children and not adults.
